## House Passes Historic Healthcare Reform Bill

Final Approval of Senate Bill heads to the White House for Signature



**Washington, D.C. | March 21, 2010**—The U.S. House of Representatives gave final approval Sunday to some of the most significant health policy changes in almost 40 years, expanding insurance coverage to nearly all Americans and handing President Barack Obama a historical victory. The final vote on the House's package—which included the Senate-passed bill, HR 3590, the **Patient Protection and Affordable Care Act**—was passed late Sunday evening by a narrow margin of 219 to 212 votes. The House needed 216 votes for passage. This sweeping healthcare bill heads to the White House for President Obama to sign into law. As one of the President's top domestic priorities, once this bill becomes law, it would usher in the largest changes in the \$2.5 trillion U.S. healthcare system's history since the creation of Medicare in 1965. **bt**



## Organization of DOT's Federal ITS Program

A corporate-style "board of directors" – the Intelligent Transportation Systems (ITS) Management Council – develops and directs Federal ITS policy and ensures the effectiveness of the ITS program. Members include the Under Secretary of Transportation for Policy, the Assistant Secretary for Transportation Policy and Intermodalism, USDOT's Chief Information Officer and the Administrators of the Federal Highway Administration (FHWA), the Federal Motor Carrier Safety Administration (FMCSA), the Federal Transit Administration (FTA), the National Highway Traffic Safety Administration (NHTSA), the Research and Innovative Technology Administration (RITA), the Federal Railroad Administration (FRA) and the Maritime Administration (MARAD).

In May 2006, the RITA Administrator became chair of the ITS Management Council, giving the RITA Administrator responsibility for the strategic direction and management oversight of USDOT's ITS program. In November 2006, this leadership and policy-making authority were further delineated in a signed memorandum of understanding between FHWA and RITA.

The Intermodal Surface Transportation Efficiency Act of 1991 (ISTEA) established a Federal program to research, develop, and operationally test Intelligent Transportation Systems (ITS) and to promote their implementation. The program was designed to facilitate deployment of technology to enhance the efficiency, safety, and convenience of surface transportation, resulting in improved access, saved lives and time, and increased productivity.

The ITS program carries out its goals through research and development, operational testing, technology transfer, training and technical guidance in the areas of intelligent vehicles, advanced traffic and transit management, commercial vehicle operations, public safety, traveler information, and intermodal freight.

## Health IT | How the new bill may affect BDPA Members

The following highlights of **H.R. 4872, *The Health Care & Education Affordability Reconciliation Act of 2010***, represent opportunities and challenges for BDPA Members, families, or small business stakeholders if passed.

- **TITLE I, Coverage, Medicare, Medicaid, and Revenues**  
**TITLE I, Subtitle C: Medicaid**

**Sec. 1303. CMS-IRS data match to identify fraudulent providers.** This section allows the Secretary of Treasury to share IRS data with HHS employees to help screen and identify fraudulent providers or providers with tax debts, and to help recover such debts. Strict controls on the use of such information to protect taxpayer privacy either will create new positions or extend inter-agency IT personnel.

**TITLE I, Subtitle F: Other Provisions**

**Sec. 1501. TAA for communities.** This section appropriates half of a billion (**\$500M**) dollars per year for fiscal years 2010 through 2014 in the **Community College and Career Training Grant** programs for community colleges to develop and improve educational or career training programs. BDPA Chapters may opt to work with one or more Community Colleges to develop and deliver courseware across all STEM disciplines.

- **TITLE II – Health, Education, Labor, and Pensions**

**TITLE II, Subtitle A: Education**

**Sec. 2102. Student Financial Assistance.** This section provides **\$13.5 billion** in mandatory appropriations to the Federal Pell Grant program.

**Sec. 2104. Investment in HBCU/MSIs.** This section amends section 371(b) of the Higher Education Act by extending funding for key programs at HBCU/MSI's to 2019, including programs that help low-income students attain degrees in the fields of **science, technology, engineering or mathematics (STEM)** by the following annual amounts: **\$100 million** to Hispanic Serving Institutions, **\$85 million** to HBCUs, **\$15 million** to Predominantly Black Institutions, **\$30 million** to Tribal Colleges and Universities, **\$15 million** to Alaska, Hawaiian Native Institutions, **\$5 million** to Asian American and Pacific Islander Institutions, and **\$5 million** to Native American non-tribal serving institutions. Sec. 2104 addresses BDPA's primary target markets and CS-STEM initiatives.

**TITLE II, Subtitle B: Health**

**Sec. 2303. Community Health Centers.** Increases mandatory funding for community health centers to **\$11 billion** over five years (FY 2011 – FY 2015). Task or IT career opportunity for infrastructure upgrades. **bt**

## Government 2.0 | Visit [www.hhs.gov](http://www.hhs.gov) HHS Gets \$162 Million for Health IT

*The U.S. Department of Health and Human Services (HHS) announced in March an additional \$162 Million in Recovery Act (ARRA) investment to advance widespread meaningful use of Health IT. Final awards of state health information exchange cooperative agreement program work to build health information exchange infrastructure throughout the states.*

**Washington, D.C.**—U.S. Department of Health and Human Services Secretary Kathleen Sebelius recently announced awards to help states facilitate health information exchange and advance health information technology (health IT). Funded by the American Recovery and Reinvestment Act of 2009, March 2010's awards are part of the \$2 billion effort to achieve widespread meaningful use of health IT and provide use of an electronic health record for every citizen by the year 2014. Every state and eligible territory has now been awarded funds under this program.

The health information exchange HIE awards announced in March provide approximately \$162 million to 16 states and qualified state designated entities (SDEs) to facilitate non-proprietary health information exchange that adheres to national standards. Health information exchange is critical to enabling care coordination and improving the quality and efficiency of health care.

These cooperative agreements were awarded under the authority of Title XIII of ARRA, the Health Information Technology for Economic and Clinical Health (HITECH) Act which amends Title XXX of the Public Health Service Act by adding Section 3013, State Grants to Promote Health Information Technology. Section 3013 provides for the awarding of competitive grants to promote health information technology. On February 12, 2010, HHS awarded \$385 million to 40 states and SDEs. The awards announced today complete the awarding of cooperative agreements funded by this program.

BDPA's SITES programs, such as the IT Showcase may be eligible for HHS Grants when supporting health IT initiatives. BDPA Chapters may contact HHS, BDPA-DC or visit [www.grants.gov](http://www.grants.gov) for additional grant information.




